ASCP's Political Action Committee (ASCP-PAC) is a restricted fund established for the express purpose of influencing the outcome of a political issue, legislation, or the election of political candidates. When a PAC donates funds to a political campaign fund, it is an expression of the ASCP-PAC membership's support for the policies supported by, and political position being taken by the recipient. PAC donations are a mechanism for advancing ASCP's legislative and policy agenda by assisting certain political candidates in securing or maintaining elected offices.

ASCP-PAC raises funds exclusively from ASCP membership, and the Federal Election Commission (FEC), which is authorized by the Federal Election Campaign Act, strictly regulates its activities. Contributions made to this fund may only be accepted from ASCP members. All ASCP active members are considered members of ASCP-PAC. Any contributions disbursed from this fund may only be donated to political parties, other PACs, or election campaign funds for political candidates seeking office or re-election in a federal election.
